Michael Baur is Associate Professor in the Philosophy Department at Fordham University, and Director of Fordham's Natural Law Colloquium. He holds a PhD in philosophy from the University of Toronto and a J.D. from Harvard Law School, and has published articles on Kant, Fichte, Hegel, Aquinas, Lonergan, Adorno, Rawls, Heidegger, and Gadamer.

Joseph Boyle is a professor in the Department of Philosophy at the University of Toronto. He is a fellow of St. Michael's College where he served as Principal for a decade.
